### Standing Authority to Payment Agent - Authority under Securities and Futures (Client Money) Rules

This authority covers money held or received by the Subscriber's broker in Hong Kong in one or more segregated account(s) on my/our behalf ("Monies").

Unless otherwise defined, all the terms used in this authority shall have the same meanings as in the Securities and Futures Ordinance and the Securities and Futures (Client Money) Rules as amended from time to time.

The Subscriber hereby authorises its broker, as indicated above, to deduct Monies from the Subscriber's brokerage account and pay to Cyberquote fees for the provision of Market Data without giving notice to the Subscriber.

This authority is valid for a period of 12 months from the date written below.

The Subscriber may revoke this authority by giving written notice to Cyberquote or the Subscriber's broker. Such notice shall take effect upon the expiry of two weeks from the date of Cyberquote's or the Subscriber's broker's actual receipt of such notice.

The Subscriber understands that this authority shall be deemed to be renewed on a continuing basis without written consent if Cyberquote issues a written reminder at least 14 days prior to the expiry date of this authority, and the Subscriber does not object to such deemed renewal before such expiry date.

This authority has been explained to the Subscriber and the Subscriber confirms he/she understands the contents of this authority.

### 支付代理的常設授權 - 《證券及期貨(客戶款項)規則》

本授權涵蓋在香港持有或收取並存放於一個或多個獨立賬戶內的款項("款項")。

如非另有界定，本機構所使用的所有詞彙與“證券及期貨條例”及不時修訂的“證券及期貨(客戶款項)規則”具有相同涵義。

如上所述，訂戶特此授權其券商從訂戶的券商賬戶中扣除款項，並在不另行通知訂戶的情況下向 Cyberquote 支付市場數據費用。

本授權由下列日期起 12 個月內有效。

訂戶可以向 Cyberquote 或訂戶的券商發出書面通知，以撤回本授權。有關的生效日期為 Cyberquote 或訂戶的券商收到該等通知後兩週起計算。

訂戶明白 Cyberquote 若在本授權的有效期屆 14 日前發出書面通知，以提醒本授權即將屆滿，而訂戶沒有在本授權屆滿前反對此授權續期，本授權應當作已被續期。

已向訂戶解釋此授權，訂戶確認他/她了解此授權的內容。
